SCHEDULE "B"
LOTTERY LICENCING FEES

All Licence Fees are due and payable prior to any Lottery Scheme being conducted.

BINGO

The following Licence fees are payable for single or series lottery schemes. For Bingos where a jackpot is carried over, only the opening amount shall be used to calculate the fee.

A bingo Licence if less than \$5,000.00	\$100.00
A bingo Licence if more than \$5,000.00	6% of payout
Building Rental	\$125.00

NEVADA TICKETS

Single or part of a series	\$100.00/ Event
A Single booth event or series of booth events	\$150.00/ Event

RAFFLE

Raffle per month (daily)	\$75.00
For raffle where the total prize is less than \$1,250.00	\$100.00
For raffle Licence where the total prize is more than \$1,250.00	6% of prize

CASINO

For each table, wheel of fortune, blackjack or any other game \$100.00 per table

AMENDMENTS

Any amendments to any Licences requested by a Licence Holder shall be assessed an additional fee of \$50.00 per amendment.

SCHEDULE "C"
PENALTIES

Failure to submit a Statement of Account for any lottery scheme within the allotted timeframe as indicated in this Bylaw	
Failure to adhere to age restrictions where a lottery scheme is being conducted	Possible suspension of Licence
Failure to post Licence or rules	Same as above
Disbursement of proceeds not in accordance with approved application	Six (6) Month Suspension
Provide false information of any kind	Two (2) Year Suspension
Three infractions for an individual or Licence Holder	Lifetime Suspension

Every person or organization that violates or fails to comply with any of the conditions of this Bylaw will be denied the right to have their Lottery Licence renewed and may have their existing Lottery Licence revoked
