6. Matters and arising from Minutes/committee report:

The SAO gave an option to Council that they had the option to not fill the vacancy on Council and leave the seat vacant for the year, have a by-election, or appoint a councillor. Council could, for a variety of reasons, ask the Minister to reduce the size of Council, to commence the next calendar year.

After deliberation, Mayor Blake asked the SAO to draft a calendar showing the dates required to hold a by-election. All agreed.

### 7. Financial Matters:

- 7.1 Proposal for banking services-Royal Bank of Canada \*(RBC)/Canadian Imperial Bank of Canada (CIBC)/First Nations of Canada (FNBC).
- Hamlet received three proposals for banking services.
- the Director of Finance gave his experience in banking with CIBC.
- the SAO/Director of Finance suggested if Council change banks, that the process should take between 3-6 months to complete the transfer.
- the CIBC rate of return for investment was a full .06% better than the RBC.
- both the RBC and the CIBC provide similar equivalent services, including the ability to finance larger projects.
- the SAO explained that the FNBC had only submitted their proposal minutes before the meeting so
  there had been no time to fully analyze their proposal but their interest rate on investments was
  much lower than either the RBC or CIBC.
- the RBC agreement has expired so if there is a change to be made, this will be the appropriate time to make the change.

Motion to transfer the Hamlet's Banking requirements to the Canadian Bank of Commerce from the Royal Bank of Canada. Administration is to complete the change as quickly as possible and open operating accounts, capital investment accounts, gas tax accounts, investment accounts and credit card accounts, as required.

### 10. Correspondence / Information Items

- 10.1 Brownlee LLP judgement for the Hamlet Vs Henry Paul Itsi
  - o Mr. Itsi bought a truck from the Hamlet and did not pay for it.
  - The council of the day instructed the SAO to move forward to collect the payment.
  - Brownlee LLP requested a judgement on the matter.
  - Council must now seek payment or forgive the debt (\$36,000+).
  - Council instructed the SAO to pursue payment.
- 10.2 Nehtruh-EBA Consulting study of Terrain and Geohazard Mapping, Slope Stability Review and Evaluation of Stabilization Options Fort Pherson, NT
  - Rat River Development Corporation Ltd hired a consultant to do the subject study in 2019.
  - This study concentrated on the church and the adjacent cemetery but may have identified further areas that need study.
  - The council may need to follow up with a land use plan.
  - Administration will review the study details and report back to Council.
- 10.3Letter from the Minister of Justice seeking consultation on NWT Policing priorities.
  - The SAO is to draft a letter to invite the Minister of Justice to invite him to Council to meet and discuss the community concerns regarding the importation of drugs and alcohol into the community and the proposed methods of enhancing RCMP policies and procedures to give them more power of enforcement, as the Fort McPherson Liquor Plebiscite Order is clearly not working.
